Flexibility as a Guiding Principle

The school prioritizes FLEXIBILITY as a guiding principle:

- Keeping students together with their friends and teachers and preserving WSOC's vibrant educational program is paramount
- Staying connected with each other and the social spirit that will guide us

Flexibility in Practice

- The tuition agreement withdrawal deadline (July 31) is being reviewed by the Board. Announcement next Wednesday.
- Tuition payments already made towards 2020-21 can be credited toward future tuition, or back to you, should you choose to pause your enrollment or withdraw.
- Flexible and Adaptive Tuition approaches for 2020-21 -- working together in our financial life
- Continuing with expense reductions without disrupting core programs and support functions
- Planning for an operating deficit next year to be funded by cash reserves

Overview of Recent Financial Information

• Current cash reserves are healthy

• Half a year's operating expenses covered by reserves

• 2020-2021 forecast

- Currently enrolled 280 students
- Forecasted operating deficit of \$750K-\$1.25M, depending on enrollment and instruction scenario
- Utilizing PPP Loan and cash reserves to offset the deficit

Adaptive Tuition Modeling

OVERVIEW

In a distance learning scenario due to COVID-19, WSOC is creating adaptive tuition models. This is our pathway to giving back tuition dollars to the community, as best we can.

CURRENT WSOC PROGRAMS

- **STAR Fund** make grants available from this fund for short term needs for the 2020-2021 school year
- **Tuition Adjustment** for sustained family needs due to longer-term financial concerns
- Additional Adaptive Tuition Practices additional information coming in a Financial Town Hall in early August

Evolving Public Health Guidance

Overall Guidance Timeline:

- Beginning of June:
 - California Dept of Education
 - California Dept of Public Health Initial Guidelines
 - Orange County Healthcare Authority communication
- June 18th:
 - California Dept of Public Health Facial Coverings
- June 25th:
 - American Academy of Pediatrics
- Beginning of July:
 - Multiple school districts announce plans
 - LA, SD, Newport-Mesa
- July 17th:
 - California Dept of Public Health Updated Guidelines

WSOC Plans - On Campus Learning

- Healthy hygiene procedures maximized & facilitated
- Strict adherence to **sick policies** for all community members expanded for COVID-19
- Protocols for **health screening** procedures all students and staff (Parent Square)
- Maintain **consistent cohorts** throughout the day; restrict mixing between groups as much as possible
- Proper safety precautions for **food preparation** & hot lunch programs
- Revised **drop off and pick up procedures** to support distancing utilizing multiple designated entrances with a staggered approach
- Sanitation protocols: throughout the day, end-of-day, and deep clean for campus exposure
- Student assemblies, performances, camps on-hold initially
- Outside spaces being expanded and maximized
- **Physical distancing** per CDPH and AAP guidance
- **Policy on facial coverings** will align with the California Department of Public Health guidelines
- Spaces on campus planned for isolation of ill individual
- Protocols being finalized for **positive COVID-19 cases** on campus

Highlights of Latest Public Health Guidance

California Department of Public Health Schools & School-Based Programs COVID-19 Re-Opening Guidance

Highlights from CDPH Update - July 17th, 2020:

- County Data Monitoring to determine timeline
- Criteria for when classrooms and the school will close due to COVID-19 cases on campus
- Testing recommendations are included for the first time
- Waiver for early re-opening of Grades 1-8 waiver (to be further understood)
- More defined recommendations regarding facial coverings in alignment with the latest CDPH policy
- Further recommendations regarding collaboration with OCHCA
- Further highlights importance of training and implementation

2.	Close contact (†) with a confirmed COVID- 19 case	 Send home Quarantine for 14 days from last exposure Recommend testing (but will not shorten 14- day quarantine) School/classroom remain open 	Consider school community notification of a known contact
3.	Confirmed COVID-19 case infection	 Notify the local public health department Isolate case and exclude from school for 10 days from symptom onset or test date Identify contacts (†), quarantine & exclude exposed contacts (likely entire cohort (††)) for 14 days after the last date the case was present at school while infectious Recommend testing of contacts, prioritize symptomatic contacts (but will not shorten 14-day quarantine) Disinfection and cleaning of classroom and primary spaces where case spent significant time School remains open 	 School community notification of a known case
4.	Tests negative after symptoms	 May return to school 3 days after symptoms resolve School/classroom remain open 	Consider school community notification if prid awareness of testing

Early Childhood Modifications

On Campus Modifications

- Classes/cohorts will stay together through the day and in aftercare with same teacher & assistant
- Maximize outdoor time
- Meals eaten outside with more space between children
- Lunch and snacks provided from home
- Increased hand washing & outdoor hand washing station
- Dedicated drop off and pick up area


Under consideration:

- Remaining open for essential worker childcare in the event of a shutdown.
- Camp programs
- Parenting classes & social community building
- Remote support with weekly newsletter & facetime with student

Under Consideration

- Waiver from local health authority to open in fall
- On campus enrichment programs in afternoon to foster creativity in arts and movement as permitted
- Avenues for community- parents and students to remain connected
- Innovative ways to foster and maintain the love for learning

Grades 1-8

On Campus Modifications

- Arrival and Dismissal Procedures
 - Separate entrance/exit for upper and lower school
 - Staggered pick up and drop off times

• School Day Revisions

- Grade level cohorts
- Single desks appropriately distanced
- Limited classroom transitions
- Recess in designated areas
- Limiting sharing of materials
- Singing and flute playing will be outside


Outdoor Classrooms

On Campus Modifications

• Health and Safety

- Reduced classroom transitions: each grade will keep the same classroom for the duration of the block they are in
- Single desks/tables appropriately distanced
- Sanitation before and after all class changes
- Hand washing station installed outside
- Additional stalls added in girls bathrooms
- No food storage or preparation in student kitchen
- Increased use of outdoor space for all classes
- CIF sports postponed until December

Under consideration:

• Afternoon enrichment classes for art/practical art/movement while Learning Beyond the Classroom is in session
